- The Society will give to objects deposited with it the same care they would receive if they were its own property. Objects here for conservation, loan, purchase or gift will be insured by the Society; objects on deposit for identification, examination, photography or bequest consideration will not be insured. The Society assumes no responsibility for loss or damage resulting from war, invasion, hostilities, rebellion, natural disaster, or defects in the object.
- 2. It rests with the discretion of the Society as to whether, or how long, objects lent to it shall be exhibited to the public.

3. The Society subscribes to the International Council of Museums' "Joint Professional Policy on Museum Acquisition" and the UNESCO Convention on the Means of Prohibiting and Preventing the Illicit Export, Import and Transfer of Ownership of Cultural Property. In receiving gifts, donations, making purchases or surrendering loans of imported objects, the Society will comply with these doctrines and all government customs regulations.

- 4. The lender reserves ownership of all copyright, whether under common law or statute, in the objects lent. Subject to this reservation, the lender authorizes and licenses the borrower:
 - To exhibit the objects, exercising due care that they are photographed or a). reproduced only as specified;

b). to photograph the objects and file prints for record;

c). to reproduce photographs in copyrighted institutional publications;

- d). to lend photographs to schools, colleges or other educational organizations for study;
- e). to make lantern slides for use by the borrower or for loan to such educational organizations;
- f). to lend photographs for reproduction in copyrighted newspapers and periodicals;

to permit such publications to make their own negatives for copyrighted reproduction;

h). to make, or to permit commercial photographers or publishers to make, copyrighted

reproductions for sale.

Provided that no such photograph, slide or reproduction, unless protected by statutory copyright, be offered at unrestricted sale, that any photograph or slides lent for purposes stated above must be marked "Courtesy of (name of owner of the object)," and that statutory copyright in any reproduction must be assigned to the owner of the object on his demand.

- Upon surrender of this receipt, or upon the written order of the lender or his duly authorized and accredited agent (as designated herein) or successor in interest, any object lent to the Society may be withdrawn upon reasonable notice.
- 6. In the event that an object, the ownership having meanwhile passed by bequest or gift, is not to be returned to the original depositor, the new owner must establish, in advance of such return, his authority to receive it. The legal representatives of a deceased depositor should notify the Society, enclosing a certified copy of his authority, and furnish the name of the new legal owner.

7. Any object if not withdrawn by the depositor or his agent in a reasonable time (60 days) after notice in writing by the Society may be returned express collect or placed

in storage at the depositor's risk and expense.
